may be satisfied.
3. That the Comptroller of Public Accounts has further certified
that the said corporation has failed and refused to revive its
right to do business prior to the first day of January next
succeeding the date of forfeiture of its right to do business
and provided by law:
4. That the above determination and findings of fact have been
approved by the Attorney General of Texas.

IT IS THEREFORE ORDERED that the charter of the above named
Corporation be and the same is hereby forfeited without judicial ascertainment
and made null and void, and that the proper entry be made upon the permanent
files and records of such corporation to show such forfeiture as of the date hereof.
