Said judgment provides that penalty imposed by Subsection 12(a), Art. 5221b, V.C.S. shall be due on the contribution shown above from the date of delinquency until paid at the rate of 1 per cent per month, provided that such penalty on contributions for any one calendar quarter shall not exceed 25 per cent, and for \$ 15.45 costs of suit; said judgment is of record in Vol. 400 Page 322, Minutes of Said Court.

There is still due on said judgment \$ 519.73 with penalty on contributions imposed by Subsection 12(a), Art. 5221b, V.C.S. for each quarter from 1st day of March 19 67, at the rate of 1 per cent per month until paid or until a maximum of such penalty of 25 per cent is reached for each quarter, and thereafter such judgment shall bear interest at the rate of 6 per cent per annum; together with \$ 15.45 costs of suit.
