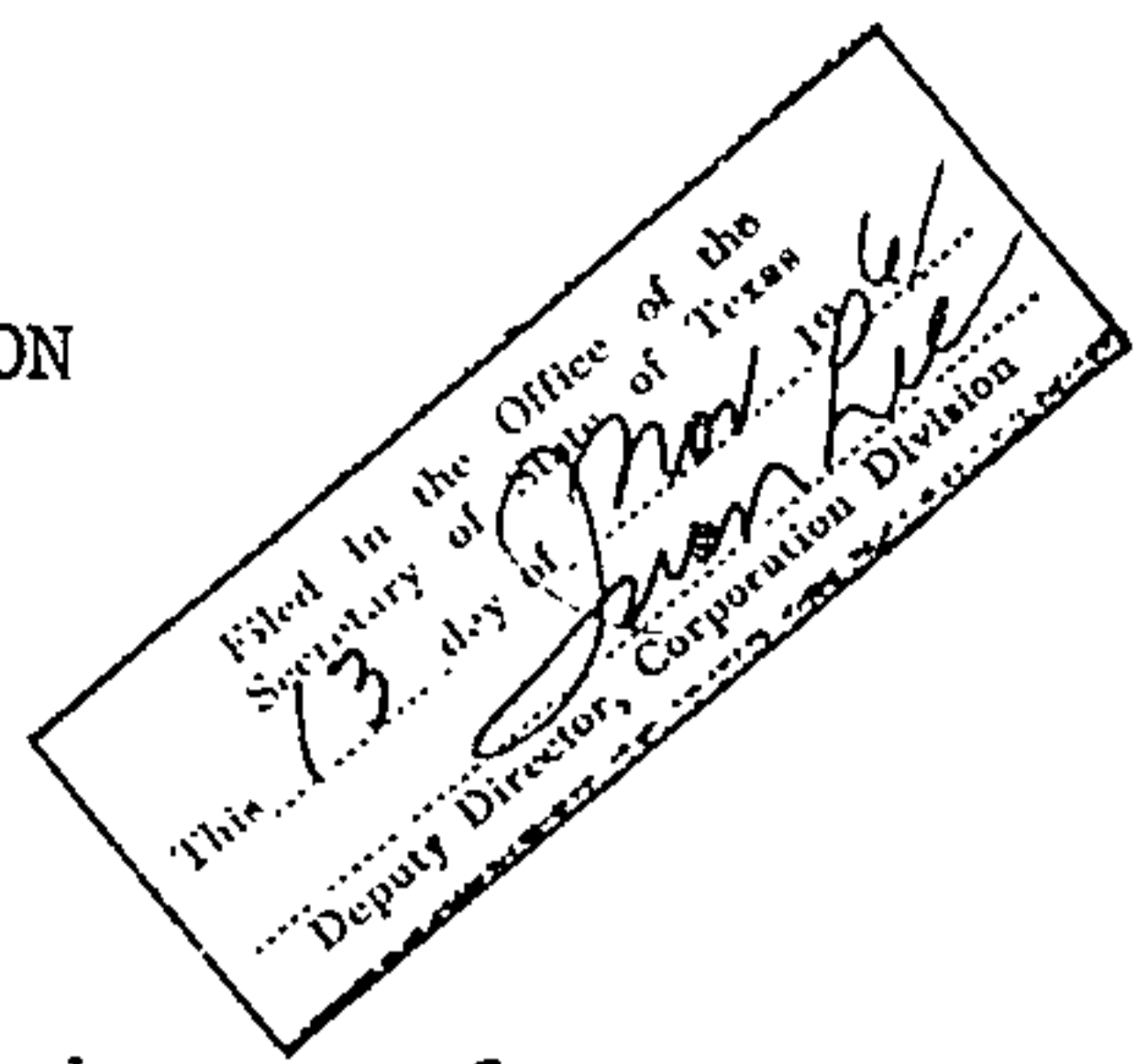


ARTICLES OF INCORPORATION  
OF  
U. S. SONICS, INC.



We, the undersigned natural persons of the age of twenty-one years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is U. S. SONICS, INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose or purposes for which the corporation is organized are:

Cleaning and processing of all missile, aircraft and machine parts; also non-metallic materials, and to own, operate and use any machines or devices in connection therewith.

To do a general business of selling, leasing or manufacturing of equipment, parts and materials.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 100,000 of the par value of \$1.00 each.

ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of its shares consideration of the value of TEN THOUSAND DOLLARS (\$10,000.00), consisting of money, labor done, or property actually received, which sum is at least equal to ten percent (10%) of the total capitalization of said corporation and not less than ONE THOUSAND DOLLARS (\$1,000.00).

## ARTICLE SIX

The Post Office address of its initial registered office is 916 Kirby Building, Dallas 1, Texas, and the name of its initial registered agent at such address is Edwin A. Nesbitt.

## ARTICLE SEVEN

The number of Directors constituting the initial Board of Directors is three (3), and the names and addresses of such persons who are to serve as Directors until the first annual meeting of the Shareholders, or until their successors are elected and qualified, are:
